CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Vice Chairman Blair called the meeting of the Ohio Lottery Commission to order at 12:00 p.m. The meeting was held in person and via teleconferencing.

ROLL CALL

APPROVAL OF MINUTES OF JULY 13, 2022

Chairman Blair presented to the Commission for approval the minutes from the July 13, 2022, meeting. Commissioner Rickel made a motion to approve the minutes, seconded by Commissioner Sweeney. The motion was affirmatively voted upon by the seven Commissioners present.

Chairman Blair moved to approve the Administrative Rules as presented in Proposed Form, with Commissioner Sweeney offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

RESOLUTION TO APPROVE VIDEO LOTTERY GAME THEMES

Mr. LoPresti presented a Resolution to approve 19 Video Lottery Game Themes for inclusion in the video lottery game theme library.

Chairman Blair moved to approve the Resolution, with Commissioner Sweeney offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

FINANCIAL REPORT

Office of Finance Deputy Director Greg Bowers provided to the Commissioners a financial update for the month of July 2022.

Sales from Traditional Lottery games for month of July, the first month of the fiscal year were \$395.5 million, which was a 7.8% increase from last year's record setting July.

Sales from Classic Lotto in state jackpot game also increases over last July by nearly 36%. In total draw based games were up over last year by \$45.1 million or 26.5%.

VLT Revenue from VLTs for the month was \$118.0 million. Net Profit from that equaled 438.6 million, which was \$1.0 million less than last year or 4.0%.

The accounting department continues their development of the annual financial report. This summer marks the beginning of developing the next budget for fiscal year 2024 and 2025. The lottery budget submission is due to OBM on October 28th, 2022. The finance department is also involved in incorporating sports gaming into our financial reporting model before the program launch on January 1, 2023.

DIRECTOR REMARKS

The Director informed the Commission that the LPEF transfer for the month of July 2022 will be \$135 million which is \$28 million over our commitment and \$16 million more than July of 2021.

The Director indicated that the high Mega Millions Jackpot boosted of this. The jackpot rolled approximately 28 times and there was a lot of media excitement with this being the second highest jackpot ever. This run increased revenue in the last three months by 18 million more in profits.

The Director also announced that Michael Gonzalez Deputy Director of Product Innovation as the recipient of the 2022 NASPL Powers Award. Mike received the award for his diligent and innovative work amongst the Mega Millions Consortium. Mike has been a leader with the other states' product development teams to help the consortium come up with proposals to differentiate the game from Powerball.

Director McDonald shared an overview of the Cash Explosion 35th anniversary show that took place at the State Fairgrounds on Sunday July 31st. Over 5,000 fans were in attendance and participated in the days festivities which included raffle prizes, cash giveaways, eight live contestant draws, and a \$350,000 top prize winner. Chairman Blair gave opening remarks and introduced the Governor's prerecorded welcome message which was played on large video screens throughout the Taft Coliseum. Positive feedback has been received from many who attended. A highlight video of the show was played for the commissioners.

The Director then announced that the Combined Charitable Campaign will kick off this month. Last year the Lottery exceeded our goal of \$46,600, this year our goal is the same. The Director gave a shot out to the coordinators for all their work.

Director McDonald recognized Deputy Director of Responsible Gambling Karen Russo and was pleased to report that the agency won an award from the National Council on Problem Gambling for our Keep it fun, Ohio campaign. Keep it fun, Ohio focuses on problem gambling prevention and provides the public with tools and tips to play responsibly when they choose to play Ohio lottery games. Director also recognized Commission Jon Hughes for all his work too.

Director McDonald also announced after 31 years of service to the Ohio Lottery, Deputy Director Karen Russo has announced her retirement effective September 1, 2022. The Director gave an overview of her various positions within the lottery over the years.

Director Russo stood up and gave some final remarks.

Sports Gaming Operations Manager Jon Dillinger gave a status update his department's work and progress to implement lottery sports gaming.

With no further business before the Ohio Lottery Commission, Chairman Blair informed Commissioners that the next meeting will be held on Wednesday, September 14, 2022, at 12:00 p.m. via teleconferencing and in person.
