The Applicant or Principal further agrees that the Executive Director may make investigations in order to satisfy the conditions for licensing retailers. These investigations may include, without limitation, credit reviews, inspections of applicant's premises and inspection of law enforcement and other official records. Applicant or Principal acknowledges reading and understanding the conditions set out on this authorization and agrees to observe and be bound by them. Applicant or Principal acknowledges that the Executive Director is not obligated to issue a license and can suspend or revoke the license at any time. Each permit holder holding a license as a Lottery Retailer agrees to be bound by and observe the conditions listed on the application and in Chapter 3770 of the Ohio Revised Code and the Ohio Administrative Code.
