Video Lottery Sales Agent Fine Schedule

The Ohio Lottery has established rules and regulations establishing the framework for video lottery sales at racetrack locations. Violation of those rules and regulations may subject VLSA to sanctions including suspension or revocation of licenses or the levying of fines.

OAC 3770:2-3-05 Video lottery licenses; suspension or revocation.

(C) When required to so by the Administrative Procedure Act, the director shall afford a hearing to a video lottery sales agent affected by an order to suspend or revoke a video lottery license. Such hearings shall be conducted by the director or a hearing examiner designated by the director and shall comply with the requirements for adjudication hearings set out in the Administrative Procedure Act.

(D) If a video lottery sales agent's video lottery license is revoked, a video lottery agent may reapply, but any subsequent application shall require submission of a new application and payment of a separate application fee and licensing fee, as applicable, and shall only be submitted after any waiting period for reapplication, if any, established by the director, has expired.

OAC 3770:2-3-06 Video lottery licenses; fines.

(A) As determined by the director, monetary fines may be imposed upon a video lottery sales agent who does not comply with the Lottery Act, all rules, regulations, terms and conditions, policies, orders and directives adopted, promulgated or issued by the commission or the director which may include but may not be limited to a determination that a video lottery sales agent has failed to comply with or violated any provisions set forth in paragraphs (A)(1) to (A)(3) of rule 3770:2-3-05 of the Administrative Code.

(B) Any fines under this section may be in addition to or in lieu of a suspension or revocation under rule 3770:2-3-05 of the Administrative Code.

As required by the director, a video lottery sales agent shall provide the lottery with an updated video lottery terminal floor plan which sets forth the number of video lottery terminals, the names of the video lottery terminal providers (and the number of video lottery terminals provided by each different video lottery terminal provider), and the location of each video lottery terminal.</p>

A VLSA permits an individual less than twenty-one years of age to play a video lottery game and to win a video lottery jackpot	\$10,000 per occurrence. A VLSA who sets the theoretical payout of a VLT to below eighty-five percent.	\$25,000 per machine	3770:2-10-60 (D) The value of video lottery prize winnings and the number and type of different video lottery prize winning combinations available for each video lottery game shall be established by the director and shall be subject to approval through a resolution of five commissioners present at a meeting of the commission prior to the video lottery game being available to a video lottery sales agent for sale to video lottery participants. No resolution shall be approved unless there is a projected average return to video lottery participants of eighty-five per cent or more during the expected lifetime of the video lottery game using standard methods of probability theory

<p>Failure to comply with ongoing duty to report changes in financial condition, criminal activities, and other incidents as set in policy.</p>	<p>\$50,000</p>	<p>3770:2-3-05 (A)(3) The director may suspend or revoke a video lottery license if, at any time after issuance of a video lottery license, the director determines that a video lottery sales agent no longer meets the requirements and standards for issuance of a video lottery license as set forth in the Lottery Act, commission rules, regulations, policies, orders and directives adopted, promulgated or issued by the commission or the director.</p>
<p>If the director has determined that a VLSA provider should be subjected to a criminal background check and is convicted of any of the offenses set forth in divisions(C)(1) to (C)(5) and (E)(1) to (E)(2) of Section 3770.05 of the Revised Code, or any other criminal violation which as determined may negatively impact the integrity of the lottery.</p>	<p>\$50,000</p>	<p>3770:2-3-05(2) The director may suspend or revoke a video lottery license if a video lottery sales agent, or any of its video lottery principals or any person who the director has determined should be subjected to a criminal background check are convicted of any of the offenses set forth in divisions(C)(1) to (C)(5) and (E)(1) to (E)(2) of section 3770.05 of the Revised Code, or any other criminal violation which as determined by the director may negatively impact the integrity of the lottery.</p>
<p>Failure to complete the transfer of funds required in order to settle the weekly invoices sent to the VLSA.</p>	<p>10% of the transfer</p>	<p>3770:2-3-10 (E) Penalties for non-transfer of funds. The director may impose penalties for the failure of a video lottery sales agent to transfer funds to the lottery in a timely manner. Penalties may include, but are not limited to, monetary penalties, modification of license, immediate suspension or revocation. The director may adopt internal management regulations elaborating on any terms regarding the collection of sales revenues due and owing from the video lottery sales agents.</p>
